No fowl or poultry other than chickens may be kept, harbored or permitted to reside on real property situate in any zoning district other than a R-40 and R/C.

No Roosters are permitted. Only hens are allowed.

If you have more than (4) chickens, when this application is submitted, you will be permitted to keep them as long as complaints are not received and once any of the present chickens are removed you will not be permitted to replace them above the limit of four (4).

The tract of land on which the chickens are to be kept shall contain a single or two-family dwelling only and shall be occupied as such.
