RESOLUTION NO. 1016

A RESOLUTION OF PENN TOWNSHIP, YORK COUNTY, PENNSYLVANIA, APPROVING THE REQUEST OF GRANDVIEW PLAZA HANOVER, LLC TO APPLY TO THE PENNSYLVANIA LIQUOR CONTROL BOARD FOR THE ISSUANCE OF AN ECONOMIC DEVELOPMENT LICENSE (EDR) TO BE LOCATED AT 1418, Unit #1 BALTIMORE STREET, HANOVER, PENN TOWNSHIP, YORK COUNTY, PA.

WHEREAS, Section 461 of the Liquor Code (47 P.S. Sec 4-461), authorizes the Pennsylvania Liquor Control Board to approve, in certain instances, the issuance of an Economic Development License, where sales of liquor and malt or brewed beverages are legally permissible in the municipality receiving the license; and

WHEREAS the Liquor Code requires the applicant to obtain from the receiving municipality a Resolution approving the issuance of such a license for the purpose of local economic development concerning the applicant's intent to apply for an Economic Development License to be issued by the Pennsylvania Liquor Control Board, prior to an applicant's submission of an application to the Pennsylvania Liquor Control Board; and

WHEREAS, the Liquor Code stipulates that, prior to adoption of a Resolution by the receiving municipality, at least one public hearing be held for the purpose of permitting individuals residing within the municipality to make comments and recommendations regarding the applicant's intent apply for and Economic Development License to be located within the receiving municipality; and

WHEREAS an application for transfer filed under the Act must contain a copy of the Resolution adopted by the municipality approving the transfer of a liquor license into the municipality.

NOW, THEREFORE, BE IT RESOLVED, that Grandview Plaza Hanover, LLC, has requested the approval of the Penn Township Board of Commissioners of for the proposed filing of an application for the issuance of an Economic Development License, pursuant to Section 461 of the Liquor Code, to the premises to be located at 1418, Unit #1, Baltimore Street Hanover, Penn Township, York County, Pennsylvania, 17331 with the understanding that said issuance must be approved at a later date by the Pennsylvania Liquor Control Board; and


BE IT FURTHER RESOLVED that the Penn Township Board of Commissioners has held the properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license application; and

BE IT FURTHER RESOLVED that Penn Township Board of Commissioners, hereby approves, by adoption of this Resolution, the issuance of an Economic Development License by


the Pennsylvania Liquor Control Board to the premises to be located at 1418, Unit #1, Baltimore Street Hanover, Penn Township, York County, Pennsylvania having determined that the issuance of such license to the applicant for said premises will promote economic development in Penn Township and further determining that there is no evidence that the proposed economic development license will adversely affect the welfare, health and morals of Penn Township and its residents
